### **NOTICE TO ALL EXHIBITORS**

All dogs six (6) months and older must have an individual ASCA registration, LEP number or an ASCA QTracker number to compete in ASCA sanctioned Obedience/Rally Trials. A dog will be allowed to be shown at the trial where the handler applies for an ASCA tracking number. No dog without an ASCA individual registration, LEP number or ASCA QTracker number may compete in any ASCA Obedience/Rally Trial. Photo copies or originals of registration or tracking number papers must be presented to the Registration Table upon request when entering ASCA sanctioned Obedience/Rally Trials. Each non-ASCA registered dog will be required to have an ASCA Tracking Number. There is a one-time fee of \$10/ dog. At the time of applying for the tracking number, the individual owner must also be an ASCA member (minimum membership type of Service is required). ASCA membership does not need to be maintained in subsequent years. If your dog does NOT have a tracking number, you can get the form by following this link. <https://www.asca.org/wp-content/uploads/2016/04/trackapp.pdf>. Then include that form and check or Money Order payable to ASCA with your entry. Forms will also be available at the trial. **Bitches in heat will not be allowed to compete.**

**DIRECTIONS:** (coming from north or south of Galt on Hwy 99) take the Central Galt exit, and follow the signs to "A" St. Stay on A St. which becomes Harvey Rd after you pass the elementary school on your left. Go past Sargent Rd. - the house will be on the left. Address is 9860 Harvey Rd. A silver van should be in the drive. House is brick w/blue trim - white fence and circular drive.

**OR, if you're coming from I-5 north or south of Galt,** take the Twin Cities Rd/Walnut Grove exit. Go east toward Galt. Take a right on Christensen Rd (about 8 miles from I-5) then a left on Harvey Rd (3rd stop sign). The house will be about 1/2 mile on the right. Address is 9860 Harvey Road.

## ASCA® Service Membership and Tracking Number Application

**Beginning 1/1/2003 for non-ASCA® registered dogs** – In order to have ASCA® qualifying legs tracked and to receive ASCA® titling certificates, each non-ASCA® registered dog will be required to have an ASCA® Tracking Number. This is a one-time fee of \$10/dog. At the time of applying for the tracking number, the individual owner must also be an ASCA® member (minimum membership type of "Service" is required). ASCA® membership does not need to be maintained in subsequent years. **It will be the responsibility of the owner to identify to ASCA® the show(s) and leg(s) earned when applying for a Tracking Number for those ASCA® qualifying legs earned from 1/1/2003 until submission of application.**

## ►FREQUENTLY ASKED QUESTIONS◄

### **Do I have to have a tracking number to compete?**

No, you do not need a tracking number in order to compete in Agility or Stock.

You will need a tracking number to enter an Obedience trial or Tracking Test.

Your dog does not have to be a purebred to receive a tracking number from ASCA.

### **Why would I need or want a tracking number for my dog?**

If you would like to have your dog's points and titles recorded by ASCA®, and if you'd like to receive title certificates in the mail for your accomplishments, you might want to obtain a tracking number.

### **How much is the total cost for a tracking number?**

In order to obtain a tracking number for your dog, you must be at least a "Service" member. The cost for Service Membership is **\$10**.

Your membership is good for one year; however, it does not need to be maintained in subsequent years, unless you want to obtain another tracking number for another dog after your membership has expired.

This membership fee is **in addition** to the tracking fee of **\$10** per dog. A tracking number is good for the lifetime of the dog. If you only have one dog, the total cost would be **\$20**. For two dogs, the cost would be **\$30**, for three, the cost would be **\$40**, etc.
