All entries must be on the official ASCA entry form with proper fees included; these forms can be found at www.asca.org Exhibitors are responsible for the accuracy of the entry and the classes entered. Bitches in season are not allowed to compete. Withdrawals of entries accepted until the Pre-entry closing date. Thereafter, no refunds.

All dogs six (6) months and older must have an individual ASCA registration, LEP number or an ASCA QTracker number to compete in ASCA sanctioned Obedience/Rally Trials. A dog will be allowed to be shown at the trial where the handler applies for an ASCA tracking number. No dog without an ASCA individual registration, LEP number or ASCA QTracker number may compete in any ASCA Obedience/Rally Trial. Photocopies or originals of registration or tracking number papers must be presented to the Registration Table upon request when entering ASCA sanctioned Obedience/Rally Trials.

At the time of applying for the tracking number, the individual owner must also be an ASCA member (minimum membership level of "Service" is required). ASCA membership does not need to be maintained in subsequent years. If your dog does NOT have a tracking number, you can get the form by following this link: <https://asca.org/wp-content/uploads/2022/06/qtsvcapp.pdf>

Then include that form and check or money order payable to ASCA with your entry. Forms will also be available at the trial.

Bitches in heat will not be allowed to compete.

Trial hours are 7:00 am until 4:00 pm

Grounds Rules:

1. NO overnight & NO Day of RV parking.
2. NO smoking allowed on the grounds.
3. You will not be allowed to leave your vehicle idling in the parking area.
4. Crating – please bring a clean towel or mat to put under your crate. NO x-pens in the building.
5. Keep dogs on leash while not working. **Note:** farm animals and cats on property. Air your dog on gravel driveway. Do not air on grass, plants, barn, or equipment. **Note:** water is well water and safe to drink.
6. **Exhibitors are responsible** for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

Directions to the show grounds: 19681 Brandt Road, Lodi, CA 95240

From the north or the south: Take Highway 99 to Lodi, exit Highway 12/88 east. Proceed about 5 miles east, turn left on Highway 88 toward Lockeford. Proceed about ½ mile, turn right on Brandt Road. Facility is on corner of Brandt Rd and Clements Rd, first driveway on left after crossing Clements Rd intersection.

From the west: Take Highway 12 through Lodi, continue east on Highway 12/Kettleman Lane to Highway 88. Turn left toward Lockeford and proceed about 2 ½ miles, turn right on Brandt Road. Facility is on corner of Brandt Rd and Clements Rd, first driveway on left after crossing Clements Rd intersection.

FREQUENTLY ASKED QUESTIONS

What is the total cost for a QT number?

The cost for membership (required) is **\$20 per owner** if not already a current member.

- Membership expires in one year and only needs to be renewed if applying for another dog after membership has expired.
 - Owners will need to renew their membership each year to keep track of dog's scores/titles in the online member portal. To sign up for an online account, please visit www.asca.org and click "Register" under Member Login (must have member ID#).
- Membership fee in addition to the QT number fee of **\$20 per dog**.

A QT number is good for the lifetime of the dog and will not expire.

For one dog with one owner, the total cost is **\$40**. For two dogs with one owner, the total cost would be **\$60**. For one dog with two owners, the total cost would be **\$60**. (This is assuming no owners are current members or under 18).

Do I have to have a QT number to compete?

- You do not need a QT number to compete in ASCA Agility, Stockdog or Dock Jumping events, unless you want to earn ASCA titles.
- You must have a QT number to compete in ASCA Obedience, Rally and Tracking Tests.

Why would I need or want a QT number for my dog?

To have ASCA keep track of your scores and receive title certificates for your accomplishments.
