COVID-19 CONSIDERATIONS:

Participants are required to follow state and local guidelines as they apply to COVID-19 safety. Currently, those guidelines are in a state of flux. The CDC has established that fully vaccinated people can safely go without masks outside as long as they are not in a crowd. (This event is not considered a crowd.) If conditions change, we will require participants to follow the COVID-related regulations at the time. Do not come if you feel sick. Do not come if you are not comfortable being around others that are following state/local COVID guidelines. Everyone is encouraged to maintain 6' social distancing. Avoid shaking hands or hugging. Avoid touching dogs that are not your responsibility.

Entry information:

Pre-registration required: no day-of-workshop entries will be accepted. Entries close September 7 or when limits are reached. Entries received after the close will not be accepted. Fees for each dog entered: \$12 first run and \$8 for each additional run. No refunds after close of entries. Complete the entry form and sign its waiver; unsigned forms will not be accepted. Use a separate entry form for each dog.

\*\*Special discount!! Enter your dog in both of WASOC's Obedience trials being held on Oct 2 and receive \$5 off that dog's first run at this workshop. No discount on additional runs. Discount is for same dog entered in the workshop plus both AM and PM Obedience trials.\*\*
